#### COUNCIL RESOLUTIONS - 20 July 2023

## Voting Delegates for Western Australian Local Government Association (WALGA) Annual General Meeting

The Shire President, Councillor Karen Chappel and the Deputy Shire President, Councillor Ken Stokes were elected as Voting Delegates for the WALGA AGM.

#### Local Government Cyclone Seroja Funding Programs

Council directed the CEO to submit the enhancement of the Recreation Centre for evacuation purposes as a project under the Local Government Resilience Fund and to submit the Clean Up of Abandoned Properties as a project under the Community Benefit Fund-both these grant funding arrangements are made possible by the co-funded Disaster Recovery Funding Arrangements Post Cyclone.

#### Early Childhood Education and Care in Morawa

Council:

- 1. Directed the CEO to submit an Expression of Interest for the Growing Regions Grant Program for the Morawa Early Childhood Education and Family Centre prior to the 1 August 2023 closing date.
- 2. Authorised the Chief Executive Officer to approve a development application for an Early Childhood Education and Family Centre on Lot 409 on Deposited Plan 210931, being 26 Prater Street Morawa, subject to appropriate notice being given in accordance with clause 64 of the deemed provisions.
- 3. Accepted the opinion of probable cost of construction for Morawa Early Childhood Education and Family Centre as \$3.5m and accepted that the Shire's cash contribution towards the project, if successful in obtaining 70% growing regions program funding, would be up to \$1,050,000.
- 4. Approved the Shire President to write to REED's board of management to formally request negotiations on a facility lease and terms of reference for a partnership arrangement to ensure the proposed facility is professionally managed. Noting that all agreements are subject to funding being received and the project being delivered and does not tie the Shire to the delivery of the project in anyway and to any timeframe.

#### Review of Council Delegation Register and Authorisation Register

Council adopts the July 2023 review of the Delegation Register being a continuation of the delegations currently in place with a few minor amendments as noted in the report and adopts the Authorisation Register being a continuation of the current authorisations.

#### Adoption of ADM08 Child Safe Awareness Policy

Council adopted ADM08 Child Safe Awareness Policy.

Council acknowledges and approves the date of the next ordinary meeting of Council to being held on Thursday, 10 August 2023 at 6:30pm and approves the amending of the commencement of the Audit and Risk Committee to being held on Thursday, 10 August at 6:00pm.

#### LOCAL GOVERNMENT ORDINARY ELECTION **CLOSE OF ENROLMENTS** Shire of Morawa

ROLL CLOSE: 5:00 PM Friday, 25 August 2023

You may be eligible to be enrolled to vote in the local government elections on 21 October 2023 if you live in or are an owner or occupier of rateable property in the Shire of Morawa.

#### Residents

You are automatically enrolled to vote if you are on the State Electoral Roll as at 5:00 PM Friday, 25 August 2023. If you are not already on the State Electoral Roll and meet the eligibility criteria, or if you have changed address recently, you must complete an enrolment form.

#### **Enrolment Forms**

You can enrol or update your details online, or download an enrolment form, via the Western Australian Electoral Commission website (www.elections.wa.gov.au/enrol). Forms are also available from the Australian Electoral Commission (www.aec.gov.au). Enrolments and updates must be completed and received by 5:00 PM Friday, 25 August 2023.

#### Non-Resident Owners and Occupiers

If you are a non-resident owner or occupier of rateable property in the Shire of Morawa and are on the State or Commonwealth Electoral Roll, you are eligible to enrol to vote. If you are not on the State or Commonwealth Electoral Roll and own or occupy rateable property in the Shire of Morawa you may be eligible to enrol to vote. This applies if you were on the last electoral roll for the Shire of Morawa prior to May 1996 and have owned or occupied rateable property in the district continuously since this time. Please contact your local government for details. Owners of land who were on the last Local Government roll continue to retain that status until they cease to own the rateable property to which the enrolment relates. Occupiers do not have continuous enrolment and should contact the Shire of Morawa to confirm their enrolment status. To be eligible to enrol as an occupier, you will need to have a right of continuous occupation under a lease, tenancy agreement or other legal instrument for at least the next three months following the date of the application to enrol.

#### Joint Owners and Occupiers

If a rateable property is owned or occupied by more than two people, a majority of the owners/occupiers may nominate two persons from amongst themselves who are on either the State or Commonwealth Electoral Roll, to enrol as owner/occupier electors.

A body corporate that owns or occupies rateable property may nominate two people who are on either the State or Commonwealth Electoral Roll to enrol as owner/occupier electors.

#### Enrolment Forms – Non-Resident Owners and Occupiers Only

Enrolment forms can be obtained from local governments and must be lodged with the Chief Executive Officer by 5:00 PM Friday, 25 August 2023. Further information can be obtained from the Shire of Morawa.
